ON JANUARY 19, 1995 AT APPROXIMATELY 2210 HOURS TROOPER GWEN KRIEGER ATTEMPTED TO STOP A VEHICLE ON INTERSTATE 93 IN CONCORD FOR SPEEDING. WHILE DOING SO, THE VEHICLE FLED FROM THE AREA AT A HIGH RATE OF SPEED WHERE THE TROOPER FOLLOWED IT GETTING OFF THE HIGHWAY AT EXIT 16: ONTO SHAWMUT STREET AND FINALLY ONTO RANDOLPH STREET IN CONCORD WHERE IT CAME TO A STOP. AFTER WALKING TOWARD THE STOPPED VEHICLE THE OPERATOR PUT THE VEHICLE INTO REVERSE IN AN ATTEMPT TO RUN DOWN TROOPER KRIEGER. IT THEN PROCEEDED FURTHER DOWN RANDOLPH STREET AND CAME TO A STOP AGAIN WHERE BOTH THE OPERATOR AND PASSENGER FLED THE VEHICLE ON FOOT. A MALE JUVENILE PASSENGER WAS APPREHENDED SHORTLY THEREAFTER AND RELEASED TO HIS PARENTS AND THE KNOWN MALE OPERATOR IS STILL AT LARGE. THE OPERATOR WILL BE CHARGED WITH ATTEMPTED FIRST DEGREE ASSAULT; RESISTING ARREST; DISOBEYING A POLICE OFFICER AND SPEED. ASSISTING AT THE SCENE WERE MEMBERS OF THE STATE POLICE AND MEMBERS OF THE CONCORD POLICE DEPT.

PRONOUNCER -- KRIEGER - (KREE' GER)

(CONCORD) -- A STATE TROOPER HAD A CLOSE CALL IN CONCORD (NEW HAMPSHIRE) DURING THE NIGHT.

POLICE ARE LOOKING FOR A DRIVER THEY SAY TRIED TO RUN THE TROOPER DOWN AFTER A SHORT CHASE.

SHORTLY AFTER TEN P.M., TROOPER GWEN KRIEGER (KREE' GER) TRIED TO STOP A SPEEDING CAR ON INTERSTATE 93. THE CAR SPED OFF, TOOK THE EAST CONCORD EXIT AND STOPPED A SHORT DISTANCE AWAY. POLICE SAY WHEN KRIEGER APPROACHED, THE DRIVER THREW THE CAR INTO REVERSE, TRIED TO RUN HER DOWN, THEN DROVE OFF AGAIN. THE DRIVER AND PASSENGER THEN BAILED OUT.

POLICE CAUGHT A MALE JUVENILE WHO WAS A PASSENGER. THEY SAY THEY KNOW WHO THE DRIVER IS AND ARE LOOKING FOR HIM.

**(C)**

POLICE ARE SEARCHING FOR A MOTORIST WHO FLED AFTER ALLEGEDLY TRYING TO RUN OVER A STATE TROOPER IN CONCORD LAST NIGHT. OFFICIALS SAY THE INCIDENT OCCURRED WHEN TROOPER GWEN KRIEGER STOPPED A VEHICLE ON RANDOLPH STREET FOR SPEEDING ON I-93. THE OPERATOR WILL BE CHARGED WITH ATTEMPTED FIRST DEGREE ASSAULT, RESISTING ARREST, DISOBEYING AN OFFICER AND SPEED.
